MESSAGE FROM CMD

Dear SClans,

My good wishes to you and your families for a joyous Gudi Padwa and a happy New Year, wishing you peace, prosperity and good health!!

The coronavirus pandemic has placed extraordinary challenges on the mankind, in general, and the nation, in particular, at a time when the country is already grappling with the economic slowdown. The humanitarian toll of the contagion, the massive scale of the outbreak, its overwhelming speed and uncertainty has left in its wake a disorientation, a feeling of losing control, a sense of unease and fear that keeps increasing. All the more challenging for the SCI has been the necessity to continue performing given the constraints of the recently imposed lockdown.

I take this opportunity to address you all, acknowledging the challenging phase that stares in our face today, but at the same time imploring you to stand the test of time and garner all the strength and resilience to sustain ourselves through these difficult times.

Once again, I acknowledge and express my sincere appreciation of the agility, compassion, courage and resilience displayed by the employees in this moment of crisis and would like to share my view on overcoming this unique challenge viz. first, safety of all of us is paramount; second – business continuity is the key.

Please take care of yourselves and your loved ones. Let's endeavor, as an SCI family, to keep calm however trying the circumstances, doing what it takes to be done one day at a time and we cross over together and emerge stronger than before.
