## FLEET CIRCULAR

## <u>Sub : Deputation of 2nd Mate FG (20/30) & MEO Class IV Engineer (3EO/4EO) as</u> <u>Technical Assistants On-Staff in various departments</u>

Application Dates: 05/08/2022 to 19/08/2022

The Shipping Corporation Of India Ltd., a Navratna PSU, has a significant presence on the global maritime map. SCI occupies the Numero Uno position with its large and diversified fleet, operating in nearly all segments of shipping viz. Container services, liquid and dry bulk services, offshore services, passenger services and break-bulk services. The Company also mans and manages vessels on behalf of various Government bodies.

Applications are invited from Regular Officers holding 2<sup>nd</sup> Mate FG or MEO Class IV CoC (20/30 & 3EO/4EO) of SCI Fleet for engagement as Technical Assistant On-staff ashore in various Departments.

### Requirement: 10 Nos. (MEO Class IV and 2nd Mate FG CoC holders)

Eligibility Criteria:

- a) Should be regular SCI officers.
- b) Should not have sailed/worked with any other shipping company.
- c) Should have completed minimum 06 months sea time after obtaining COC of MEO Class IV or 2nd Mate CoC.
- d) Should not be on authorised leave for more than 06 months as on 01.07.2022.

Age Criteria: The maximum age shall not exceed 35 years as on 01.07.2022.

### **Terms and Conditions:**

- The officers will be engaged as Technical Assistants On-staff ashore with prevailing INSA MUI wages.
- Service as On Staff ashore will be treated as continuous service without break in service between fleet and shore.
- The period of engagement will be 6 months with two extensions of 3 months each at the sole discretion of the SCI Management.
- If concerned officer wants to revert back to sea (Floating Staff) prior completion of engagement period or not willing to accept extension, he shall provide minimum 30 days' notice in writing. Also if Company desires of reverting him back to sea (Floating Staff), it shall be given 30 days' notice in writing.
- SCI shall provide accommodation subject to availability.
- Conveyance to attend office is to be arranged by the officer himself during the period of engagement as Technical Assistance On-staff.
- Medical treatment/attendance if any as per the prevailing INSA-MUI agreement.

#### **Documents Required**

- b) Copy of CDC indicating the experience, with validity for minimum 12 months
- c) Copy of Passport with validity for minimum 12 months.

#### **Criteria for Selection:**

The criteria for selection will be on Interview by the selection committee appointed by SCI Management.

#### **Selection Committee:**

The selection committee shall be constituted with representatives from: Technical Department -02 persons from Technical Dept. Fleet Personnel Department -01 person.

#### Selection Process:

- b) The interviews will be held in a staggered manner depending on the reporting of the candidates for interviews as they sign off from the vessels.

- e) The panel of waitlisted candidates will be kept valid for a year.
