SCI has planned to conduct walk in interview on **09.06.2025 (Monday)** for recruiting Crane Operators for MSV on contract basis. **(06 nos. of vacancies)**. Eligible candidates are requested to undergo through following instructions and appear for interview.

**Technical Qualification and Experience:**

The following technical qualifications and experience are required for the Crane Operator:

- 1) Diploma in Mechanical Engineering from recognized polytechnic or National Trade Certificate in the trade of Fitter/Marine Fitter or Diesel / Motor Mechanic or Machinist or Welder issued by National Council of Training in Vocational Trade, Ministry of Labour, Government of India (NCTVT) or by the Industrial Training Institute of State Government (ITI).
- 2) Minimum One Year of Rank experience of Crane Operator.

**OR**

Crane Operator having minimum One year of Rank experience on board any MSVs of ONGC (Samudra Nidhi, Samudra Sarvekshak, Samudra Prabha or Samudra Sevak).

Preference will be given to the candidates who are approved by ONGC and have sailed on board any ONGC MSVs.

**Other requirements/Necessary documents for Crane Operator:**

- a) Must be in possession of valid Indian CDC, Passport, PAN Card, SID, INDOS no. and PCC (Validity within 6 months)
- b) Must have completed all required STCW courses, HUET & STSDSD and crane operator certificate from DG approved institutes.
- c) Must be medically fit for sea service as per present medical rules.
- d.) Upper Age Limit is 65 Years.

**Proposed wage structure of the Crane Operator:**

Crane Operator will be engaged on direct contract with prevailing day rates offered by SCI. Rest terms and conditions will be as per Collective Bargaining Agreement i.e. NMB-INSIA.

**Selection procedure:**

- a) On selection day at given time all applicants to muster/gather in selection hall (to be notified). Personnel who are on board will be interviewed on Video call/Voice call whichever is available.
- b) Designated officers from FP Dept. and Operation division of SCI will be present in Selection Hall for selection as per requirement.
- c) After verification of all documents and selection in interview, candidates will be sent for medical examination.
- d) Thereafter medically fit Crane Operator will be posted on the vessels subject to completion of joining formalities, etc.
