Sub - Sub-Adjudication of Order of Demerger dated 22.02.2023 issued by the Ministry of Corporate Affairs

Reference – Letter bearing no. SCI/DGM(A, PR & FS) /2023 dated 13.11.2023

You have applied to adjudicate the stamp duty on the Order of the Ministry of Corporate Affairs dated 22nd February 2023. By the said Order, MCA has approved the Scheme of Arrangement between M/s Shipping Corporation of India (Demerged Company) and M/s Shipping Corporation of India Land and Assets Limited. (Resulting Company). In view of your application, I have to inform you that

- 1. Application shall be addressed to the Additional Controller of Stamps, Mumbai.
- 2. Application shall be filled in the format which is attached to this mail.
- 3. Other documents which are required are mentioned in the application. You will have to file documents/information which are mentioned in the application.

By the aforesaid Application, you have sought an exemption from the stamp duty in view of the Notification dated 12th October 2023 of the Revenue and Forest Department. However, by the said Notification, an exemption from the stamp duty is given on the Instrument of Conveyance under Article 25 of Schedule I of the Maharashtra Stamp Act. By the said notification, an exemption from the stamp duty on the Order of MCA sanctioning the Scheme of Arrangement under sections 230 to 234 of the Companies Act 2013 is not given.
