VOTING THROUGH ELECTRONIC MEANS:

- 1) In compliance with the provisions of Section 108 of the Act, read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended from time to time, and Regulation 44 of the SEBI Listing Regulations and in terms of SEBI circular no. SEBI/HO/CFD/CMD/ CIR/P/2020/242 dated December 9, 2020, the Company is providing its Members the facility to exercise their votes electronically, through the evoting services provided by NSDL, on all the resolutions set forth in this Notice. The instructions for e-voting are given herein below.
- 2) The remote e-voting period commences on Sunday 10.09.2023 at 09:00 AM and ends on Tuesday, 12.09.2023 at 05:00 PM. During this period, Members holding shares either in physical form or in dematerialized form, as on Friday. 08.09.2023, may cast their vote electronically. The e-voting module shall be disabled by NSDL for voting thereafter. Those Members, who will be present in the AGM through VC / OAVM facility and have not cast their vote on the Resolutions through remote e-voting and are otherwise not barred from doing so, shall be eligible to vote through e-voting system during the AGM.
- 3) The Board of Directors of the Company have appointed M/s Mehta and Mehta, Company Secretaries as the Scrutinizer, to scrutinize the entire e-voting process in a fair and transparent manner. Ms. Ashwini Inamdar Practising Company Secretary (Membership No. F 9409), Partner and failing her, Ms. Alifya Sapatwala Practising Company Secretary (Membership No. A24895), Partner, will represent Mehta & Mehta, Company Secretaries. THE INSTRUCTIONS FOR MEMBERS FOR REMOTE E-VOTING AND JOININ GENERAL **MEETING ARE AS UNDER:**

The remote e-voting period begins on Sunday 10.09.2023 at 09:00 AM and ends on Tuesday, 12.09.2023 at 05:00 PM. The remote e-voting module shall be disabled by NSDL for voting thereafter. The Members, whose names appear in the Register of Members / Beneficial Owners as on the record date (cut-off date) i.e. Friday, 08.09.2023, may cast their vote electronically. The voting right of shareholders shall be in proportion to their share in the paid-up equity share capital of the Company as on the cut-off date, being 08.09.2023.

How do I vote electronically using NSDL e-Voting system?

The way to vote electronically on NSDL e-Voting system consists of "Two Steps" which are mentioned below:

Step 1: Access to NSDL e-Voting system

A) Login method for e-Voting and joining virtual meeting for Individual shareholders holding securities in demat mode

General Guidelines for shareholders

Institutional shareholders (i.e. other than individuals, HUF, NRI etc.) can also upload their Board Resolution / Power of Attorney / Authority Letter etc. by clicking on "Upload Board Resolution / Authority Letter" displayed under "e-Voting" tab in their login.
- 2. It is strongly recommended not to share your password with any other person and take utmost care to keep your password confidential. Login to the e-voting website will be disabled upon five unsuccessful attempts to key in the correct password. In such an event, you will need to go through the "Forgot User Details/Password?" or "Physical User Reset Password?" option available on www.evoting.nsdl.com to reset the password.
