1	State Tax, Appeal -VI, Mumbai	In continuation of the previous disclosure dated 30th April 2024, the Company had filed an appeal against the order issued by the Deputy Commissioner of State Tax with the Joint Commissioner of State Tax (Appeal-VI), Mumbai. The Company has now received an order dated 12th June 2025 from the Joint Commissioner of State Tax (Appeal-VI), confirming a revised demand of ₹23,07,46,351 (comprising a tax component of ₹10,55,56,428 along with applicable interest and penalty), as against the original demand of ₹34,85,77,270 along with interest and penalty). The said demand is mainly on account of Mismatch of Input Tax Credit (ITC) with GSTR-2A.	ab saile Loco	The Company is currently reviewing the order in detail and evaluating the next steps in the matter. The Company is exploring all possible options to contest the demand, including filing an appeal against the same and believes that there is strong merit in the case.
