FROM THE DESK OF CMD

My dear colleagues,
I am pleased to note that the Editorial Team is bringing out a festive edition of our in-house quarterly magazine 'SCI Sandesh'.

I am extremely happy to state that we have started this financial quarter on a high. We have won two Awards and two Commendation certificates at International level Shipping Award events held in Dubai, UAE in October 2018, in addition to the several awards won earlier this year. Awards and Commendations bring cheer to the organisation and its stakeholders. It speaks volumes of the collective endeavour and team work.

The recent spurt in the charter rates of tankers (especially VLCC) is encouraging and a good sign for us. We are a highly diversified company with presence in multiple segments of the Shipping business and are reasonably well hedged. However, the tanker segment has been the largest contributors to the overall revenue. This uptick (as indicated by the rising World Scale rates) in the VLCC segment is a welcome good news.

We shall have to keenly observe the fallout and impact of the trade wars in the months to come.

The conclusion of discussions during IMO's MEPC 73 (Sulphur 2020) and the nearing of the November 4th deadline (US sanctions on Iran) are key international shipping events. While most things have been addressed this meeting; certain issues shall have to wait till MEPC 74 convenes in mid 2019. In any case, SCI is steadily gearing up for compliance by the official deadline 1st January, 2020. Hon'ble Minister of State for Shipping during his visit to SCI had expressed his deep satisfaction over the improvement seen in the organisation, as compared to his earlier visit in 2016. He had also appreciated the SCI management for maintaining high morale amongst the employees despite challenging times.

It is heartening to know that there has been an overwhelming response for 'SCI EMPOWER' the competition for young managers of SCI. I congratulate all the participating teams who have submitted their Research and Reports as part of the competition and wish them all the very best. I shall look forward to meeting and interacting with the winning teams. I would like to personally urge all employees to actively take part in all the events organised by the company from time to time as I would like SCI to be a learning organisation.

Festive season has started in India, and I hope that this festive season brings in more and more cheer to the organisation and its stakeholders. I wish all the employees and their families a very happy and prosperous festive season.

और उसके हितधारकों को उत्साहित करती है। यह हमारे सामूहिक प्रयासों तथा टीम भावना का प्रतिफल है।

टैंकरों, विशेष रूप से वीएलसीसी टैंकरों की चार्टर दरों में हालिया बढ़ोतरी उत्साहजनक है और हमारे लिए एक अच्छा संकेत है। हम शिपिंग व्यवसाय के कई हिस्सों में अपनी उपस्थिति के साथ एक अत्यंत बहुमुखी कंपनी हैं और अच्छी तरह से अपना बचाव कर रहे हैं। तथापि, टैंकर सेगमेंट कुल राजस्व के मामले में सबसे बड़ा योगदानकर्ता रहा है। वीएलसीसी सेगमेंट में क्रमिक रूप से हो रही वृद्धि (बढ़ती वर्ल्ड स्केल दरों के अनुसार) एक स्वागतयोग्य खबर है।

विश्व में कच्चे तेल की बढ़ती हुई कीमतों के कारण दुनिया भर में बंकर की कीमतों में वृद्धि हुई है, जिससे हमारे कारोबार पर भी इसका असर हुआ है। दिलचस्प बात यह है कि अमेरिका-चीन व्यापार युद्ध के चलते कुछ देशों और कुछ व्यापार खंडों के लिए अवसरों के द्वार खुल गए हैं। आने वाले महीनों में हमें व्यापार युद्धों के पतन और प्रभाव को गहराई से देखना होगा।

आईएमओ के एमईपीसी 73 (सल्फर 2020) के दौरान चर्चाओं का समापन और 4 नवंबर की समयसीमा (ईरान पर अमेरिकी प्रतिबंध) का करीब आना, प्रमुख अंतरराष्ट्रीय शिपिंग घटनाएँ हैं। यद्यपि अधिकतर चीजों का समाधान इस बैठक में प्रस्तुत किया गया है; तथापि कुछ मुद्दों को 2019 के मध्य में एमईपीसी 74 के आयोजित होने तक का इंतजार करना होगा। वैसे भी, एससीआई आधिकारिक समयसीमा 1 जनवरी 2020 के अनुपालन के लिए अपने आप को निरंतर तैयार कर ही रही है।

माननीय राज्य मंत्री ने 2016 में अपनी पिछली यात्रा की तुलना में एससीआई में इस बार आगमन के दौरान संगठन में किए गए सुधार पर अपनी गहरी संतुष्टि व्यक्त की है। उन्होंने एससीआई प्रबंधन की इस बात के लिए भी सराहना की कि चुनौतीपूर्ण परिस्थितियों के बावजूद कर्मचारियों के बीच मनोबल ऊँचा बना हुआ है।

It is heartening to note that the yeomen services of SCI's 43 vessels is recognised by US Coast Guard for providing a worldwide safety network to assist, search and rescue, co-ordination in responding to emergencies at sea. The AMVER Awards are instituted by United States Coast Guard aiming to provide quick and efficient rescue of disabled and distressed ships at sea, saving lives and ensuring continuity of shipping operations.

AMVER is a worldwide voluntary reporting system sponsored by the US Coast Guard. A computer based global ship reporting system, which is used worldwide by SAR (Search and Rescue) authorities for arranging assistance to persons in distress at sea.

The **AMVER** (Automated Mutual-Assistance Vessel Rescue) Awards were received by Shri S V Kher, Director (Bulk & Tanker Services)



along with Capt. N S Rege, DGM & Capt. M K Srivastava, DGM of (ISM & ISPS Dept) at the hands of Dr Malini V Shankar, Director General of Shipping and Consul General Edgard Kagan in a ceremony held at US Consulate Office, BKC, Mumbai on 27th August, 2018.

CMD, SCI AWARDED "OUTSTANDING ACHIEVEMENT AWARD"

a Freelance Executive Trainer imparting class room training and taking up assignments on Consultancy basis for various National Training Institutes and Central as well as State Government institutions including Ministries / Departments.

The contents covered important aspects of the RTI Act and how the same needs to be judiciously and effectively implemented, which would also strengthen the functioning of the Organization as a whole. TREE PLANTATION DRIVE AT MTI, POWAI

A Tree Plantation drive was carried out by the MTI employees and cadets in end-September 2018 during Swachhata Pakhwada. In all, 55 Saplings (25 Ficus, 10 Neem, 10 Peepal and 10 Jack Fruit trees) were planted within campus with the help of compost, organically prepared in various compost pits at MTI campus, Powai.

Deweeding and trimming activities were also carried out in this campus on this occasion. Mr. Narendra Kumar, Principal (MTI); Mr. M S Saini, DGM (MTI-Admin), some SCI officers and cadets along with contract workers were actively involved in this eco-friendly drive.



MARATHON (42.195 km) – HOW THE OFFICIAL DISTANCE CAME TO BE!

The legend of Marathon is said to have originated from the narratives of writers Lucian and Plutarch with reference to the Greco Persian Wars. In 490 BC, a Greek messenger named Pheidippides was sent to seek help from the Spartan Army when the Persians landed near Marathon in Greece. Pheidippides was a hemerodromos, a professional long distance running messenger. He is said to have first run 140-150 miles in two days to fetch the help of the Spartans and then again ran about 25 miles from the battlefield in Marathon to Athens to proclaim a Greek victory. According to the Lucian story, Pheidippides died from exhaustion immediately after announcing victory to the Athenians.

Another narrative by Plutarch carries an identical tale in which the name of the runner is Eukles who completes a long run from Marathon to Athens, proclaims victory and dies of exhaustion soon after. There is, however, no contemporary record of the above narratives.

Interestingly, Herodotus, considered as the Greek 'Father of History' in his account of the Battle of Marathon has made mention of a long distance runner named Philippides. Herodotus's account of the Battle of Marathon has certain similarities to the above narratives. Herodotus writes that the Athenian runner was sent to Sparta from Athens to seek their help in fighting the approaching Persian army. The Spartans declined to engage before day of the full moon after which Philippides ran back to Athens. He covered a total of about 150 miles over mountainous terrains for two days.

As per historical accounts, the Greek soldiers routed the Persian soldiers at the Battle of Marathon. Majority of the defeated Persian cavalry retreated to their ships. Concerned that the Persians could attack Athens from the sea, the Athenian soldiers marched back to Athens right after their victory over the Persians. Effectively, the Athenian army marched back to their capital (Athens) from the battlefield (Marathon) covering approximately 25 miles in full battle armour. This is probably the source or origin of the myth.

The first Olympics in 1896 was designed by Pierre de Coubertin, who is considered as the Father of Modern Olympics. It is said that Coubertin came across Robert Browning's poem about Pheidippides in which the messenger died moments after announcing triumph to his countrymen. Coubertin proposed the inclusion of a 'marathon race' as part of the first modern Olympic Games scheduled to be organised in 1896 to commemorate the legend of Pheidippides. The first Olympic marathon race of 25 miles was held on 10th April, 1896. As a tribute to the Greek myth, the standard course distance was set at 25 miles (40 kilometre) in 1896 and remained the same for the next

two Olympics. Marathon races elsewhere were also being run at around the 25 miles distance.

The organisers of the 1908 London Olympics tinkered with the design of course to 26 miles to begin the race under the East terrace of Windsor Castle so that the royal family could watch the start. It was stretched further by adding a full circuit of the track in the stadium to finish it beneath the royal box. As a result, the final distance for the Olympic Marathon race held on 24th July, 1908 was around 26 miles and 385 yards (later found to be 174 yards short).

The 1908 London Olympics distance of 26 miles and 385 yards (42 kilometre and 195 metre) was considered standard and as the official length by the International Olympics Committee in 1921. An excess tolerance of 42 metre (one metre per kilometre) is allowed as a result of International Association of Athletics Federations' (IAAF) short course prevention factor to ensure that the course length is not lesser than 42.195 kilometre.

As per the IAAF (@iaaforg), the current Marathon record for men is 2 hours 1 minute and 39 seconds set by Kenyan **Eliud Kipchoge** (@eliudkipchoge) in the Berlin Marathon (@berlinmarathon) held on 16th September, 2018 bettering the previous best



timing by 1 minute and 18 seconds. The second best timing of 2 hours 2 minutes and 57 seconds was set by another Kenyan Dennis Kimetto (@denniskimetto) at Berlin Marathon in 28th September, 2014. It has thus taken about 4 years to knock off a minute and a half.

'Two Hours' The Quest to Run the Impossible Marathon by Ed Caesar (@edcaesar) is an excellent book detailing the evolution of Marathon and the runners who have made a name for themselves. Whether a runner or not, it is an interesting read. It is wonderfully researched and neatly presented.

LANDING ASHORE OF A MARINER

Writing for a company's magazine is very different from writing anything else. It is going to be on the table of everyone who is appraising you for your job performance! Let me introduce myself, I am Capt Shantanu, working as DGM, correction, as Senior Manager in liner technical dept since Oct'15. I joined SCI in Sept'00 and first ship as Trainee Navigation Officer Cadet in March'01. There are some routine goals in all professions i.e. when you join a ship as cadet, you dream of becoming a Captain one day. And off late when one becomes a Captain or Chief Engineer on board, he plans to switch over to shore job for various reasons. And thus I landed ashore on 21st October 2015 and was absorbed as a superintendent in liner technical dept.

I was preparing myself mentally for this job since long and was working harder than is usually required on board. Thus it was not really very tough for me to switch over from ship to shore job profile. It is an added responsibility as we command a single vessel as master but get to manage several vessels as a superintendent.

I believe that sailors get paid very high salary not because we do great jobs, but because we do our jobs in a perfect way day after day, leaving no chance for any mistakes because our smallest mistakes may lead to heavy financial and environmental consequences. We generally complete all on board tasks very diligently, however as I learnt soon enough, it is not practical to complete all pending jobs same day in office as mails keep coming continuously and ships need guidance, monitoring and assistance at all times and we have to be on our toes at all times while awake and sometimes throughout night in emergency situations. Superintendents are the first point of contact for master for most of their issues. Sometimes we are not able to finish all pending jobs or unable to do the job the way we want as we have to leave for home

after certain time unlike on ships where we can continue till the time the job is completed. Compare this to the situation on board where we may find someone to even type mails on our behalf!

The most difficult thing to adapt in shore office is sudden and huge (may be one tenth) reduction in the salary. However startling it may seem, this is the reality and this is not a big surprise for us as we know this fact prior joining ashore. But knowledge of the fact does not take away the pain! Our family may have committed to bring down the living standards and live a simple life for the sake of living together, it never comes down in reality and the result is hardly any savings at all and on top of that we eat away our savings slowly and steadily. Gone are the days we used to travel and spend lavishly, now we think twice before spending even ₹ 100/-.

Initially we count the days and then months after joining shore and we never realize when we stop counting days and months. The best part of working ashore is time flies like anything! The moment we get up, we hardly have a minute to waste especially for those, who have to travel around 3-4 hrs daily for work. In spite of several time and financial constraints, we are happy to see our families faces at the end of the day and that is the biggest reason why a mariner lands ashore.

My friends ask me about my experience of working in SCI office as they think SCI is falling far behind other shipping companies. I say to them that SCI can not be compared with other shipping companies as SCI is a PSU whose goal is not only to make profits.

मागे वळून पाहता...

“अरे! प्रभाकर, तू आम्हाला सोडून निघालास?” हा प्रश्न कोणी माझ्या सहकाऱ्यांनी विचारला नाही तर 16 व्या मजल्यावरील भिंती, दरवाजे, खिडक्या, खूर्ची, टेबल, कपाटे ह्यांनी विचारला. 32 वर्षांच्या माझ्या 16 व्या मजल्यावरील प्रदीर्घ सहवासामुळे माझं ह्या वास्तुंशी व वस्तुंबरोबर एक अतूट नातं जुळलं होतं.



जून 1986 ला मी 16 व्या मजल्यावर प्लॅन्स ऍंड एमआईएस ह्या विभागात रूजू झालो (जेव्हा मोगल लाइन लिमिटेड चे एससीआई मध्ये विलीनीकरण झाले). जून 1986 ते 1 ऑगस्ट 1990 मध्ये मी प्लॅन्स ऍंड एमआईएस ह्या विभागात कार्यरत होतो व 2 ऑगस्ट 1990 ते आजतागायत म्हणजे 31 ऑक्टोबर 2018 पर्यंत, जवळ-जवळ 28 वर्षे सीएमडी सेक्रेटॅरिएट मध्ये काम केले. एससीआई मधील 32 वर्षे व मुगल लाइन मधील 7 वर्षे असा 39 वर्षांच्या खूप आठवणी मनात साठवून ठेवल्या आहेत.

10 जुलाई 1979 रोजी माझी मुगल लाइन लिमिटेड मध्ये मरीन विभागात नेमणूक झाली. पण ही नेमणूक रु.600/- प्रति माह ह्या अॅडहॉक वेतनावर होती व इतर कोणतेही फायदे नव्हते. मी त्यावेळी महाराष्ट्र शासनाच्या कार्यालयात कायम स्वरूपी नोकरीत होतो पण मी जोखीम घेतली व परमेश्वराच्या कृपेने आज मी एससीआई मधून चीफ मॅनेजर ह्या पदावरून निवृत्त होत आहे.

एससीआई मध्ये जून 1986 मध्ये प्लॅन्स ऍंड एमआईएस ह्या विभागात माझी नेमणूक झाली. तेथे श्री. के. के. कोठारी साहेब होते. पुढे ते डायरेक्टर (वित्त) झाले. त्यांच्या बरोबर काम करायची संधी मिळाली. त्यानंतर माझी 2 ऑगस्ट 1990 रोजी सीएमडीच्या सचिवालयात बदली झाली तेव्हा श्री. विजय हांडा हे सीएमडी यांचे कार्यकारी सहाय्यक होते व त्यांच्या मार्गदर्शनाखाली माझी ह्या सचिवालयातील वाटचाल सुरु झाली. हे मी माझे भाग्य व सन्मान समजतो की मला सलग 28 वर्षे अध्यक्षीय कार्यालयात काम करायची संधी मिळाली. कॅप्टन पी. पी. राधाकृष्णन, श्री. पी. के. श्रीवास्तव, श्री. एस. हाजरा, श्री. अरुण कुमार गुप्ता व सध्याचे सीएमडी कॅप्टन अनूप कुमार शर्मा यांच्या सारख्या दिग्गजां बरोबर काम करायला मिळाले.

त्यांच्या शिवाय श्री. जे. सी. सेठ, श्री. आर. वासुदेवन, श्री. बी. के. मंडल व कॅप्टन बि. बि. सिन्हा ह्या ऍक्टिंग सीएमडी बरोबर सुद्धा काम करायची संधी मला मिळाली.

प्रत्येक सीएमडीचे स्वभाग वेगळे, कार्यशैली वेगळी व काम करण्याचे तासही कमी जास्त. ह्या सगळ्या गोष्टींबरोबर जुळवून घेण्याची माझी नेहमीच तयारी असायची. प्रत्येक सीएमडी कडून मला खूप काही शिकायला मिळाले. ह्या सर्व अधिकाऱ्यांच्या विश्वासास मी पात्र ठरलो हे माझे मोठे भाग्य समजतो. त्या शिवाय सर्व सीएमडींचे कार्यकारी सहाय्यक व सचिवालयातील इतर सर्व सहकाऱ्यांकडून मला खूप सहकार्य व पाठींबा मिळाला, त्या सर्वांचा मी फार ऋणी आहे.

हे ऑफीस म्हणजे माझे दूसरे घरच झाले होते. झोपेची वेळ वगळता मी घरच्यापेक्षा जास्त वेळ ऑफीस मध्येच घालवीला ह्याचा मला अभिमान आहे आणि आनंद ही वाटतो. माझा जास्तीत जास्त वेळ ऑफीसमध्ये जायचा. शनिवार, सुट्टीचे दिवस व काही वेळा रविवारी सुद्धा ऑफीसला यावे लागे. परंतु माझी घरची सर्व जबाबदारी माझ्या पत्नीने संपूर्णपणे सांभाळली. माझ्या यशात तीचा ही खूप मोठा वाटा आहे त्यामुळे मी तीचा ही ऋणी आहे. एससीआईने मला भरभरून दिले आहे व तीची कृतज्ञता व्यक्त करताना मला दिवार चित्रपटातला अमिताभ बच्चन व शशी कपूर यांच्यातल संवाद आठवतो. अमिताभ शशी कपूरला म्हणतात आज मेरे पास प्रॉपर्टी है, बँक बॅलन्स है, बंगला है, गाडी है... क्या है, क्या है तेरे पास. तेव्हा शशी कपूर म्हणतात, मेरे पास माँ है. पण मी इथे नमूद करू इच्छितो की मला एससीआई ने शोहरत, गाडी, बँक बॅलन्स, बंगला हे सर्व काही दिलेच, पण कुटुंबाची व आई-वडिलांची काळजी घेण्यासाठी चिकित्सा-उपचार सुविधा (Rule 11) देखील दिली म्हणून ह्या संस्थेसाठी मी माझे मस्तक नम्रपणे झुकवितो.

आठवणीचे मोठे गाठोडे हृदयात जपून ठेवले आहे. पण आता जागे अभावी इथेच थांबावे लागत आहे. एक नोव्हेंबरला मला काहीतरी हरवल्या सारखे वाटेल. पण आयुष्य हे असेच असते, कधीतरी, कुठेतरी थांबावेच लागते.

एससीआई मधील माझ्या सर्व सहकाऱ्यांना नमस्कार व दिवाळीच्या हार्दिक शुभेच्छा!

काळाची गरज स्वच्छता

स्वच्छतेची शिकवण हि काही आपल्याला नवीन नाही. घर आणि परिसर स्वच्छ नीट नेटका ठेवण्याचे फायदे आपण सर्व जाणतोच. जुन्या काळापासून केरकचरा साफ करण्याला महत्त्व आहे. ज्या घरात साफ सफाई असते त्या घरात लक्ष्मी निवास करते असा देखील समज आहे. थोर संत गाडगे महाराज यांनी तर या विषयावर फार मोठे समाज प्रबोधन घडवले. महात्मा गांधी यांनी केवळ स्वच्छतेचा पुरस्कार केला नाही तर स्वतः हातात केरसुणी घेऊन जागोजागी स्वच्छता घडवण्याचा प्रयत्न देखील केला.

स्वातंत्र्यपूर्व काळात महात्मा गांधी यांची एक मोठी सभा आयोजित करण्यात आली होती. ज्या गावात हि सभा होणार होती तिथे गांधीजी आधल्या दिवशीच पोहोचले होते. एका शाळेच्या भव्य पटांगणात हि सभा दुसऱ्या दिवशी होणार होती. महात्मा गांधीजींना भेटायला व त्यांचा उपदेश ऐकायला अनेक लोक वेगवेगळ्या गावांमधून येत होते. शाळेच्या काही खोल्यांमध्ये त्यांची राहण्याची व्यवस्था केली गेली होती. दुसरा दिवस उजाडण्यापूर्वी सर्वप्रमाणे गांधीजी पहाटे पहाटे फिरावयास बाहेर पडले. फेरफटका मारताना पाहतात तो काय, ज्या पटांगणात सभा भरणार होती त्या पटांगणाभोवती प्रचंड कचरा आणि दुर्गंधी येत होती. तिथे सभेसाठी आलेल्या लोकांनी प्रातःविधीसाठी ती जागा वापरली होती. गांधीजींनी कोणालाही काही न सांगता झाडूखराटा घेतला आणि स्वतः तो परिसर साफ करू लागले.

उपस्थित लोकांना जेव्हा समजले की पहाटे पासून साफसफाई करणारी व्यक्ती हि दुसरी तिसरी कोणी नसून स्वतः त्या सभेचे प्रमुख महात्माजी आहेत. तेंव्हा एकाएक धावपळ सुरु झाली. सर्वांनी हातात झाडू घेतले आणि जोमाने-एकजुटीने तो परिसर साफ-स्वच्छ केला गेला. स्वतःच्या वागणुकीतून किती मोठा बदल घडून येऊ शकतो हे यातून त्यांनी दर्शविले. स्वच्छता हि स्वतःपासून सुरु होते यात तिळमात्र शंका नाही. म्हणून हे कार्य मर्यादित अभियान स्वरूपात नाही, तर सवय स्वरूपात राबवण्याची गरज आहे. कचऱ्याचे ओला आणि वाळला कचरा असे वर्गीकरण करण्याने आणि तसे नियम करण्याने निश्चितच फायदा होणार आहे. फक्त सूझ नागरिकांनी हि सवय लवकरात लवकर अंगी बाणवावी, हीच अपेक्षा आहे.

विदेशात जाऊन आल्यावर प्रत्येकाला आपल्या देशातील स्वच्छतेवर भाष्य करावेसे वाटते, टीका कारावशी वाटते पण त्यातून काहीच सध्या होताना दिसत



नाही. स्वतःहून कार्य हाती घेतल्याशिवाय हे कार्य सफल होणार नाही. आपल्या देशाने स्वच्छतेच्या बाबतीत निश्चितच गेल्या काही वर्षात हा सकारात्मक बदल घडवला आहे, मात्र त्याचा वेग वाढणे गरजेचे आहे. वीस वर्षांपूर्वी सिगारेट आणि प्लास्टिकच्या कचऱ्याने बरबटलेली मुंबईची लोकल रेल्वे स्टेशनस आता खूप नीटनेटकी दिसताहेत. काटेकोर नियमांच्या पालनाने हा बदल शक्य झाला हे सांगणे नको. नियमांबरोबरने प्रत्येकाचा स्वच्छता राखण्याचा प्रामाणिक प्रयत्न आपल्या परिसरला आणि देशाला स्वच्छतेच्या बाबतीत क्लीन चिट मिळण्यासाठी कारणीभूत ठरेल.
