## Hon'ble Union Minister of Shipping Shri Nitin Gadkari visited SCI Head office

Shri Nitin Gadkari, Hon'ble Union Minister of Shipping, Govt. of India visited the Head Office of The Shipping Corporation of India Ltd (SCI) on Monday, the 3rd October 2016. His visit began with the inspection of Guard of Honour presented by the Cadets of SCI's Maritime Training Institute (MTI) at Powai, Mumbai. Then, Shri Gadkari paid his respects by garlanding the busts of Indian national leaders located in the central lobby of SCI Head Office.



Shri Gadkari was escorted to the SCI Board Room where the review meeting was scheduled. Prior to the review meeting, SCI's corporate film followed by a special short film on Capt. Radhika Menon was screened. CMD, SCI informed the Hon'ble Minister that Capt. Menon would be receiving her IMO Bravery Award during the IMO Session scheduled in Nov 2016. Hon'ble Minister was very impressed with the short film. He was also appreciative of the brave efforts of Capt. Menon & her team in saving the lives of seven fishermen.

While addressing SCI's senior management, Shri Gadkari shared the Prime Minister's vision for India's growth and talked about maritime led nation growth projects such as SagarMala, Inland Waterways etc. He also highlighted on India's 'Act East' policy and our recent foray into Iranian market (development of Chabahar port etc).

Hon'ble Minister reviewed the performance of SCI. He emphasized that SCI must endeavour to improve upon its operational performance and contribute to revenue growth. He also recommended that the company should look into new business opportunities and must encourage in-house innovations.



## Hon'ble Minister of State for Shipping Shri Mansukh L Mandaviya visited SCI Head office



Hon'ble Minister of State for Shipping, Shri Mansukh L. Mandaviya visited SCI on 9<sup>th</sup> September 2016. He was welcomed by the CMD, SCI alongwith Directors and senior officials of SCI. He was briefed about the recent business initiatives like formation of Inland Waterways subsidiary to undertake transportation on NW-1, NW-2 & NW-5 and increasing coastal presence by providing weekly services on west & east coast of India. The Hon'ble Minister of State took keen interest in the Inland waterways subsidiary and enquired about the business plan and modus operandi to operationilise the same. He was also concerned about the depleting Indian fleet vis a vis world fleet due to lack of long term cargo support and strengthened that it is highly essential for the energy security of the nation. He also stressed on the need for skill development in the maritime sector mainly for seafarer training and applauded the efforts of SCI in terms of providing training courses to Deck & Engine officers at Maritime Training Institutes at Mumbai & Tuticorin. He highlighted that Major Ports & SCI must join hands in this area to further augment the availability of skilled seafarers.





## From the Desk of CMD

My dear colleagues,

I am happy to present to you this edition of our in-house quarterly magazine 'SCISandesh'.

For the financial quarter ended 31st December 2016, we have reported a net profit of Rs. 12.49 crores, including other comprehensive income which is better than the results reported during the immediate preceding quarter. We are on the definite course for significant improvement and will certainly end the financial year in profit.

Nevertheless, the global shipping sector continues to sail in stormy waters and it is time that we explored hitherto uncharted waters for our survival. The resultant decline of certain asset classes has presented us with an opportunity to strategically place orders and increase our fleet size.

During the last few months we have acquired a secondhand Multipurpose Support Vessel (MPSV) 'SCI Sabarmati' and a secondhand Suezmax tanker 'Desh Abhimaan'. Very shortly, we would also be acquiring another MPSV, another Suezmax tanker and one VLGC. At the same time, we are also phasing out old and economically unviable ships.

SCI has also set up a new wholly owned subsidiary viz., 'Inland & Coastal Shipping Pvt. Ltd' which will target opportunities in the Inland Waterways, where considerable scope for growth exists. We are constantly looking for attractive opportunities in the market.

It must be our top priority to increase value for all stakeholders including Shareholders, Suppliers, Vendors, Customers, etc. I am sure that with all your support, we would be able to achieve even greater heights of success.

## अध्यक्ष एवं प्रबंध निदेशक की कलम से

मेरे प्रिय सहयोगियो,

हमारी इनहाउस त्रैमासिक गृहपत्रिका "एससीआई संदेश" के इस संस्करण को आपके समक्ष प्रस्तुत करते हुए मुझे खुशी हो रही है।

दिनांक 31 दिसंबर 2016 को समाप्त वित्तीय तिमाही में हमने रु.12.49 करोड़ का निवल लाभ दर्ज किया है जिसमें अन्य व्यापक आय का समावेश है, जो तत्काल पूर्ववर्ती तिमाही के दौरान दर्ज परिणाम से बेहतर है। हम अपने वित्तीय परिणाम में महत्वपूर्ण सुधार के लिए एक निश्चित मार्ग में आगे बढ़ रहे हैं और निश्चित तौर पर लाभार्जन के साथ ही वित्तीय वर्ष का समापन होगा।

तथापि, समग्र वैश्विक नौवहन क्षेत्र समुद्र की तूफानी लहरों से अब भी जूझ रहा है और इस प्रतिकूल समय को देखते हुए हमने अपने अस्तित्व के लिए अब तक अनछुए क्षेत्रों की संभावना का पता लगाया है। कुछ परिसंपत्ति वर्गों के परिणामस्वरूप गिरावट ने हमें रणनीतिक दृष्टि से जहाजों के नये आदेश देने और अपने नौबेड़े में वृद्धि करने का अवसर प्रदान किया है।

पिछले कुछ महीनों के दौरान हमने एक पुराना बहुउद्देशीय सहायक पोत (एमपीएसवी) 'एससीआई साबरमती' और एक पुराना सुएजमैक्स टैंकर 'देश अभिमान' खरीद लिया है। बहुत जल्द ही, हम एक और एमपीएसवी, एक सुएजमैक्स टैंकर और एक वीएलजीसी भी अधिग्रहित कर लेंगे। साथ ही साथ, हम पुराने और आर्थिक रूप से अव्यावहारिक जहाजों को भी अपने नौबेड़े से हटा रहे हैं।

एससीआई ने एक नई पूर्ण स्वामित्व वाली सहायक इकाई अर्थात, 'इनलैंड ऐंड कोस्टल शिपिंग प्राइवेट लिमिटेड' की स्थापना भी की है, जो अंतर्देशीय जलमार्गों में अवसरों को भुनाने पर ध्यान केंद्रित करेगा, जहाँ विकास के लिए काफी संभावनाएं मौजूद हैं। हम लगातार बाजार में आकर्षक अवसरों की तलाश कर रहे हैं।

शेयरधारकों, आपूर्तिकर्ताओं, विक्रेताओं, ग्राहकों, आदि सहित सभी हितधारकों के लिए मूल्य में वृद्धि करना हमारे लिए सर्वोच्च प्राथमिकता होगी। मुझे पूरा विश्वास है कि आप सभी के समर्थन से हम सफलता की नयी ऊँचाइयों को पाने में सफल होंगे।

## 66th Annual General Meeting

The 66<sup>th</sup> Annual General Meeting of SCI was held on 26<sup>th</sup> September 2016 at SCI Auditorium, 19<sup>th</sup> Floor, Shipping Corporation of India Ltd., Shipping House, 245, Madame Cama Road, Mumbai - 400021, which was attended by about 131 shareholders. Shri Anoop Kumar Sharma, Chairman & Managing Director and other functional Directors were present. The President of India's nominee Shri A. K. Singh was also present. The proceedings were conducted smoothly with the shareholders raising queries and the same being answered by the Directors. The agenda of the meeting relating to adoption of accounts for the year 2015-16, appointment of Directors liable to retire on rotation and fixation of the remuneration of the statutory auditors for the financial year 2015-16 were approved by the shareholders. The Company had also given the facility of e-voting to the shareholders which was open from 23<sup>rd</sup> to 25<sup>th</sup> September, 2016. Shareholders who could not exercise the facility of e-voting cast their votes through ballot



## Inauguration of SCI Solar Plant at MTI, Powai



On 23rd January 2017, Shri Rajive Kumar, IAS, Secretary, Ministry of Shipping inaugurated 353.5 KWP Grid connected Roof Top Solar Power Plant at Maritime Training Institute, Powai of The Shipping Corporation of India Limited in total Roof Top area of 5,650 Sq. Mtr. in the presence of Capt. Anoop Kumar Sharma, CMD SCI, Capt. B. B. Sinha, Director (P&A) SCI, Mrs. H. K. Joshi, Director (Finance) SCI, Capt. Philip Mathews, Principal MTI and others.

The payback period for EPC cost and for both EPC & O&M will be around 5 years and 7 years respectively. The life of Solar plant is expected to be around 20 years.

The power generated from the plant will be enough to cater to the need of sanctioned load of entire premises. SCI is the first organisation in Maharashtra to go for "Net Metering" with Reliance Energy, after Govt. of Maharashtra ratified the "Net Metering" in state. Thus, the excess generated power shall be exported/feedback to Grid.

SCI has vision to enhance Solar Power generation upto 1 megawatt and thereby reduce its Carbon Foot Print and contribute to Nation's goal of attaining 175 GW of renewable energy in India by the year 2022.



## SCI Mukta towing INS Virat

SCI Mukta, an Anchor Handling & Towing Vessel (AHTS) of The Shipping Corporation of India Ltd commenced towing the aircraft carrier; INS Viraat at 0700 hrs on 23rd October 2016 from Cochin to Mumbai. The INS Viraat was on the last journey and the ship, being towed back by three tugs to Mumbai for the decommissioning. It is great privilege and honour for SCI that one of its offshore vessel "SCI Mukta" has been nominated for towing operations. INS Viraat was decommissioned at Mumbai on 29<sup>th</sup> October 2016.



## SCI has reported a net profit of Rs. 7.25 Crores for Quarter Ending December 2016

The Shipping Corporation of India Ltd (SCI) has reported a net profit of Rs.7.25 crores for the financial quarter ended 31st December 2016 (Q3 FY16-17) as compared to a loss of Rs. 20 crores reported during the quarter ended 30th September 2016 (Q2 FY16-17). With this, SCI's net profit for the nine month period ended 31st December 2016 has increased to Rs. 43.16 crores.

Increase in the Operating Income of the company during Q3 FY16-2017 is mainly attributed to the increase in tanker freights. Increased revenue in the offshore and liner segments of SCI has further added to the profitability.

## SCI Sabarmati joins SCI Fleet



The Shipping Corporation of India Ltd. (SCI) accepted delivery of a secondhand MPSV on 18th November, 2016 at Singapore. This vessel is 2013 built, at Colombo Dockyard Ltd., and had lately carried out necessary modification to serve as a Multipurpose Support Vessel (MPSV). The vessel has been renamed as M.V. "SCI Sabarmati".

With this strategic acquisition, SCI's Offshore fleet has increased to 10 vessels and SCI's fleet strength has increased to 69 vessels of 5.85 million DWT.

## SCI awarded 'Best Enterprise Award' (Navratna) - 3<sup>rd</sup> Prize for WIPS activity



The Shipping Corporation of India Ltd (SCI) has been awarded the 'Best Enterprise Award (Navratna category) - Third Prize' at the 27th National Meet of Forum of Women in Public Sector (WIPS) held on 11th & 12th February 2017 at Nagpur, Maharashtra. The theme of the National Meet was 'Planet 50:50 by 2030 - step it up for equality' and the Chief Guest for the event was Hon'ble Justice (Smt.) Vasanti A. Naik, High Court of Bombay - Nagpur Bench. The award was presented by the hon'ble Chief Guest and was received by Capt. B.B. Sinha, Director (P&A), SCI along with SCI's WIPS team members. During the Meet, Capt. Radhika Menon, Serving Master, SCI was also felicitated as a WIPS Woman Achiever to commemorate her achievement of being the first woman ever to win the IMO Bravery Award 2016.

In addition to the Hon'ble Chief Guest, the inaugural session was graced by special invitee Dr. Aarti Singh, I.P.S, SP (CID), Nagpur. A panel discussion was held on the theme 'PSU's role in setting up equality' moderated by Ms. Manjusha Bhatnagar, Director (HR), B&L Co. Ltd and participated by Capt. B.B.Sinha, Director (P&A), SCI, Mr. Verghese Cherian, Director (HR), IOCL and Dr. Sanjay Kumar, Director(P), WCL. The two day Meet was attended by more than 700 delegates in addition to the several members of the WIPS APEX and Standing Conference of Public Enterprises (SCOPE).

The Forum of Women in Public Sector (WIPS) and its network has been functioning under the aegis of SCOPE since 1989 to promote growth and development of women in PSEs. SCI is one of the Corporate Life members of WIPS. The Best Activity Report award was instituted by the Forum in 1999, to recognise the PSEs / Organisations for their commendable work towards the development of women in their companies. The criteria for evaluation for the Best Enterprise Award include WIPS activities performed in Organisation, WIPS Membership drive, Database submission, CSR & Social activities conducted, Support services in their respective Organisation, participation in Training programmes, Support to WIPS from the Organisation, Training & Development activities conducted by the organisation for women employees.

## SCI's vessel 'Desh Shanti' rescues Seven Indians in Gulf of Oman



The Shipping Corporation of India Ltd (SCI) owned Suezmax tanker 'Desh Shanti' (IMO No. 9263746) was involved in a rescue operation on 03rd February 2017 in the Gulf of Oman, approximately 50 nautical miles off Fujairah, saving seven (07) Indians from the dhow 'FRTK-1'.

The rescue operation was carried out under boisterous weather conditions, strong winds gusting up to 50-60 Knots and very high sea swell. The rescue was meticulously planned saving all the 07 souls onboard the dhow.

'Desh Shanti' received distress call from the dhow 'FRTK-1' requesting immediate assistance. The distress call reported flooding of the engine compartment of the dhow. At that time 'Desh Shanti' was about 11 nautical miles from 'FRTK-1'. Upon receipt of distress call, Capt. Devendra Kumar, Master of 'Desh Shanti' intimated SCI Head Office and immediately diverted the vessel to provide assistance to 'FRTK-1'. The condition on FRTK-1 deteriorated; vessel developed list & main engine malfunctioned. Considering that the dhow was unlikely to stay afloat for long, the rescue operation was meticulously planned, pilot ladder and scrambling net was rigged on the port side to facilitate picking up of personnel from FRTK1. All seven personnel were provided with medical attention, clothing and good care / counsel by the ship staff of 'Desh Shanti'. The owners of 'FRTK-1' were informed of the rescue and the next port of call.



## Fire Evacuation Mock Drill at MTI, Powai

For the first time in the history of MTI Powai campus, a supervised formal fire evacuation mockdrill was carried out last year under the guidance of Director (P&A). The drill was conducted under the direct supervision of Principal MTI with necessary support from GM (Fire & Security).

The Mock Scenario :- Fire due to electrical short-circuit in Workshop, Sagar Gyan Building.

The purpose and the objectives of any fire evacuation mock drill were successfully achieved, i.e.

- To familiarise occupants with procedures
- To test the arrangements for disabled people
- To identify weaknesses in emergency communications procedures and systems
- To identify positive and negative reactions of staff with designated responsibilities such as Floor Marshals
- To identify any weaknesses in the evacuation strategy

Drill concluded with on-spot debriefing to the 228 participants about the observations identified by the Station Officer Vikroli Fire Brigade Station and responsible individuals. Response time for Mumbai fire brigade was 12-15 minutes and total drill time was approximately 40 minutes which is appreciable by any standards.



## Capt. Radhika Menon receives "IMO Award for exceptional Bravery at Sea"

The first female seafarer ever to receive the 'IMO Award for Exceptional Bravery at Sea'.



Captain Radhika Menon, Master of the SCI tanker MT 'SampurnaSwarajya' was awarded the 2016 IMO Award. The Award was presented to her during the IMO Bravery Awards ceremony held on 21st November 2016 at the Headquarters of International Maritime Organisation at London (U.K). Capt. Menon was nominated by the Government of India for the rescue of all seven fishermen from the fishing boat Durgamma, which was adrift following engine failure and loss of

anchor in severe weather. Capt. Menon had been selected for this prestigious award among 23 nominations received by IMO from member states. Capt. Radhika Menon has been serving with SCI for the past 25 years and was the first lady Captain in the Indian Merchant Navy.

During her speech, she thanked all the crew members who made the rescue possible without sustaining any loss to life or property. She also profusely thanked her employer, The Shipping Corporation of India Ltd for the training, continued support and encouragement provided to her during her 25 years of service with the company.

The awards ceremony was presided by Secretary General, IMO and the Chief Guest. In addition, over 200 member delegates representing various maritime nations attended the IMO Awards ceremony.

Secretary General IMO appreciated Capt Menon for the great determination and courage in leading the difficult rescue operation in the Bay of Bengal in June 2015.

On the accomplishment, Chairman & Managing Director of SCI said "It is indeed a proud & historic moment for the SCI family that India's first lady Captain, trained and nurtured by SCI, has become the world's first woman to get the IMO Bravery Award". Shri Nitin Gadkari, Union Minister of Shipping, Government of India congratulated and commemorated SCI's serving Master Captain Radhika Menon for her 'IMO Award for Exceptional Bravery at Sea' during his visit to SCI head office on 16th March 2017.





## A truly Inspirational Character

The last felicitation at Bombay Chartered Accountants Society (BCAS) was at the hands of CA Narayan Varma Sir – a senior Chartered Accountant-an epitome of ethics, Past President of BCAS, an RTI Activist and a founder member of BCAS. To have Narayan Varma Sir as one of the motivating factors has been a blessing. We lost this gem on 24<sup>th</sup> December, 2015. He touched many lives with his simplicity and humility, guided many organisations to their destinies. His contribution to the CA profession and the RTI will continue to live. He encouraged me to share my story with the world, without any hesitation. He saw a greater good through each of us. His insights were deep thoughtful and farsighted. I bow down in respect to a great personality and share my story with the SCI family. I am posted in F & A Division as Deputy Manager having joined SCI on 27<sup>th</sup> August, 2009.



"Body is a luxury, brain a necessity." Had read this quote in newspapers in a write up on Sir Stephen Hawking – a noble award winning scientist - severely challenged but known for his intelligence. The quote was an answer to the many questions bothering me at the time I was studying for Chartered Accountancy and dealing with Brain surgeries one after the other simultaneously. I'd just lost my ability to hear completely (after my 12<sup>th</sup> Boards) after the 1<sup>st</sup> Brain surgery itself. My elder sister had lost hers 2 years ago in a similar surgery and my father, 20 yrs ago in his first and only surgery. We were identified as a family of Neurofibromatosis Type-II. It's a type of hereditary brain tumor that affects sense of hearing and balance and is extremely rare. One in 50000 families has 50:50 chance of carrying it. So a big blow to us sisters came in the teenage years. Underwent 6 brain surgeries each as the tumors kept recurring despite being non malignant. Not to mention, the setback to my parents, that feeling of helplessness when you have no choice but to see your children go under the knife. Most importantly for my mother, to see her small family of 4 suffering. Her inner strength and ability to hold on to her spiritual beliefs, unrelenting support from our grandparents and uncle helped us as a family deal with the crisis.

### Adapting to life with challenges:

From having an absolutely normal childhood to now adjusting to life with daily challenges, from being a good singer to adapting to life where you are not even hearing your own voice, dealing with endless inner turmoil and observing & learning from changed behavioral patterns was difficult, but not impossible. We, as family derived strength from each other. While being in denial initially, acceptance of things not in our control made dealing with all of it easier. Lesson learnt: ONE LEARNS TO LIVE.

### Being busy helps:

To continue with our academics was the best decision we sisters made. Studies and travel to college kept us occupied to not think much about the setback. Most importantly it was to tell our parents that we were still leading an almost normal life, being with friends, sharing notes and adapting ourselves to new ways of communication (lip reading and written communication). Being occupied/busy, helped letting go of the circumstances.

Doctors had advised us against excessive use of sign language while communicating as although speech had turned a bit sluggish and had a slur in it owing to repeated brain surgeries, it was important to keep talking to exercise our vocal cords. Now that we were also not hearing our own voice, speech was bound to get softer. Also, sign language has to be technically learnt and is useful only if people communicating with you are well versed in it.

### CA Qualification and life thereafter:

The turning point was the year I joined a CA firm for my articleship. I'd passed CA foundation (entrance exam) in the first attempt, without coaching classes. This was a boost enough for me to motivate myself to keep going. The CA firm partner – CA Manju Joshi mentored me, encouraged me to face the world head on. Not to mention the kind of support provided to me by my college friends and friends at CA firm during my articleship. As the brain surgeries were happening simultaneously, it was only their encouragement that I continued appearing for CA exams further (inter and final) alongside graduation/ traveling to college and for audits.

Those were the growing years. Pursuing a professional degree without any coaching required extra efforts on my part. It was all self study without any special coaching. Finally, qualified as a CA in January 2005. It was a big morale booster for my entire family, for CA Manju Joshi and her office for their faith in my abilities despite the concurrent setbacks, that kept the sunshine called HOPE alive within.

### A word of Gratitude :

We come across many people in our journey who in some way or the other guide us, mentor us, leave an impact, and help us learn new lessons. I may have not mentioned all names, but this small piece may be considered as my way of expressing gratitude to all those who have helped me grow, my family and friends, and colleagues at SCI, my doctors and caretakers during hospital stay included. They all have helped me experience the true meaning of compassion and care. Most importantly Empathy. I bow in gratitude to all of them. Thank you for being a sunshine.

## MT 'Desh Abhimaan' joins SCI fleet

The Shipping Corporation of India Ltd. (SCI) adds another Suezmax tanker to its fleet.

The PSU is the largest shipping company in India, with a tonnage which has now reached 6.01 million deadweight, for the first time, with addition of this vessel. The company now commands a fleet of 70 owned vessels of diverse types like Very Large Crude oil Carriers, Product tankers, Bulk carriers, Cellular container vessels, Crude oil carriers, LPG/ammonia carriers and offshore vessels.

SCI has acquired the South Korean, 2007 built, secondhand Suezmax tanker from Liberian owner M/s Fidelity Shipping Inc., Liberia, on 26<sup>th</sup> April 2017. The vessel has been renamed as MT 'Desh Abhimaan' and at deadweight of 158,710 tonnes, it is now the largest vessel in SCI's fleet of seven Suezmax tankers. The vessel has a gross tonnage of 81,084 tonnes and has been classed with ABS and IRS and complies with the latest and most stringent international regulations. Energy transportation has continued to remain the core business segment for SCI and induction of this vessel in the fleet is expected to strengthen its position in the energy transportation sector.

SCI has recently also acquired a secondhand Multi-Purpose Support Vessel (MPSV), adding to its fleet of offshore vessels and the company plans to continue its foray to expand its fleet by acquisition of assets at prevailing low asset prices.

SCI's newly acquired secondhand suezmax tanker MT 'Desh Abhimaan' was welcomed at Jawahar Dweep (erstwhile Butcher Island), Mumbai Port Trust. The subject vessel was carrying cargo from Basra and was on her maiden voyage to India after joining SCI fleet.
