E-Tenders are invited by The Shipping Corporation of India Ltd., Mumbai (hereinafter referred to as “the Corporation”) for “Supply of Deck and Saloon Stores at Indian Ports in South coast of India” to the vessels owned/operated/chartered by the Corporation and/or its subsidiary/associate companies and also those for which the Corporation acts as Agents. Supply at Indian Ports in Southern Zone includes supply at ports of Chennai, Ennore, Kakinada, Kattupalli, Krishnapatnam & Tuticorin. Tenderers should **ISSA/IMPA members** and have at least two years continuous relevant experience in the last five years from the date of publishing of tender of onboard supply of deck and saloon stores at tendered ports of South coast of India.

Tender Documents are available for viewing and downloading on SCI’s e-tendering website <https://etender.sci.co.in>. The encrypted tender document is published over portal for bidders to participate in tender. Bidders have to register themselves to participate in e-tender (*they will receive system generated user id and password for logging into the e-tender portal*). Bidders have to submit their response against tender; the response is also digitally signed by individual bidder and gets saved in encrypted format in system. Detailed instructions for filling of the tender are given in the tender document.

E-tender documents will not be accepted unless the Tender Fee is electronically remitted to SCI’s Mumbai bank account before due date & time of submission. Requisite Earnest Money Deposit (EMD), as indicated above, should also be remitted to SCI’s Mumbai Bank (details given in tender document) or in the form of Insurance Surety Bond, Account Payee Demand Draft, Fixed Deposit Receipt, Bank Guarantee (including e-BG) issued/confirmed by any Commercial Bank in India (Refer to Proforma Bank Guarantee For EMD given in tender document), which should be valid for the full bid validity period plus forty five days i.e. seven and a half months, before above mentioned due date and time.

Scanned copies of remittance towards Tender Fee and EMD should be uploaded in the system along with the tender.

Tenderers are advised to submit their response well before due date and due time of submission and should not wait for last minute as E-tender would close as per system time and submission of responses will not be possible in case the deadline ceases.

Only online tenders submitted on our e-tendering portal (<https://etender.sci.co.in>) will be accepted. No manual / postal / Email / Fax offers will be entertained / accepted.
